20 YEAR LIMITED BASE WARRANTY  
3 YEAR LIMITED LAMINATED  
FINISH WARRANTY**

Snap Lock Industries, Inc. warrants SNAP LOCK base flooring covered herein to original purchaser to be free from defects in workmanship and material for a period of twenty (20) years from the date of original purchase. Snap Lock Industries warrants SNAP LOCK laminated finish (top) for a period of three (3) years from the date of original purchase. Abnormal use and/or abuse specifically nullify the warranty on that flooring.

Abnormal deterioration and/or failure under normal use of flooring covered during the warranty period, due to defects in workmanship or material shall be replaced with like (or if unavailable similar) flooring at no charge or at a prorated price as outlined below. This is the limit of the liability of Snap Lock Ind.

This warranty is void if floor tiles have been damaged by accident, unreasonable use, neglect, improper installation or any other cause not arising out of defects in material or workmanship of the flooring. The interlocking system is included under the warranty unless the flooring is disassembled improperly (pulling, tearing, etc.) See installation instructions for proper disassembly procedure. Appearance of replacement tiles will vary from those already aged and weathered and is to be expected.

REPLACEMENT COST TO THE CUSTOMER (% is based on retail list prices at the time of claim), between 0-5 years – no cost, between 6-7 years – 45% of retail price at the time of claim, between 8-20 years – 70% of retail price at the time of claim.

Authorization and verification of warranty registration must be obtained from Snap Lock Ind. 2330 W. California Ave, Salt Lake City, UT 84104, U.S.A. telephone: (800)457-0174, fax: (801)746-0180, before any merchandise can be replaced. Disassembly and re-installation are the responsibility of the buyer. Customer will be requested to send a sample of one or more full tiles and/or a photograph of the entire surface which is believed to be defective. Tile will be analyzed and pictures of accessories studied to determine validity of warranty claim. Replaced tiles will become the property of Snap Lock Ind. for disposition as directed by it.

Snap Lock Industries does not warranty the capability of any installer. Snap Lock Industries is not a joint venture with any dealer or any others and unauthorized officers of the company have no authority to bind or obligate Snap Lock Industries in any manner whatsoever.

Any alteration of this warranty shall invalidate the warranty in its entirety. No warranties expressed or implied are made beyond the conditions set forth herein.

***NOTE: Snap Lock Industries will only warrant the items covered in the warranty for the first three years under the conditions of this warranty.***
